ACKNOWLEDGEMENT OF RISK FOR MEMBERS



This acknowledgement of risks applies to all club activities I may undertake as a member of the Logan and Beaudesert Bushwalkers Inc. (the club). In voluntarily participating in the activities which are described to me by the Activity Leaders I am aware that my participation in this activity may expose me to risks that could lead to injury, illness or death or to loss of or damage to my property. I acknowledge that I may encounter weather conditions that could lead to hypothermia and being in locations where evacuation for medical treatment may take hours or days. In particular when participating in abseiling or above the snowline activities I am aware that these activities could expose me to additional hazards and risks described to me by the activity leader.

To minimize these risks I will endeavor to ensure that

1. Understand the scope of the activity.
2. Believe the activity is within my capabilities.
3. I am carrying food, water and equipment appropriate for the activity.
4. I have advised the Activity Leader if I am taking any medication or have any physical or other limitations that might affect my participation in the activity.
5. Are aware that there may not be any person with First Aid Qualification on this activity.
6. I will make every effort to remain with the rest of the party during the activity and accept the instructions of the leader of the activity.
7. I will comply with all reasonable instructions of club officers and the activity leader.
8. I have completed and am carrying the Emergency Contact and Medical Information form.

I acknowledge that activities of the club carry with them the potential risks and I hereby assume any and all risks associated with participating in any activity of the club. This form shall be construed basically to provide a release, waiver and indemnification to the maximum extent possible under the applicable laws.
